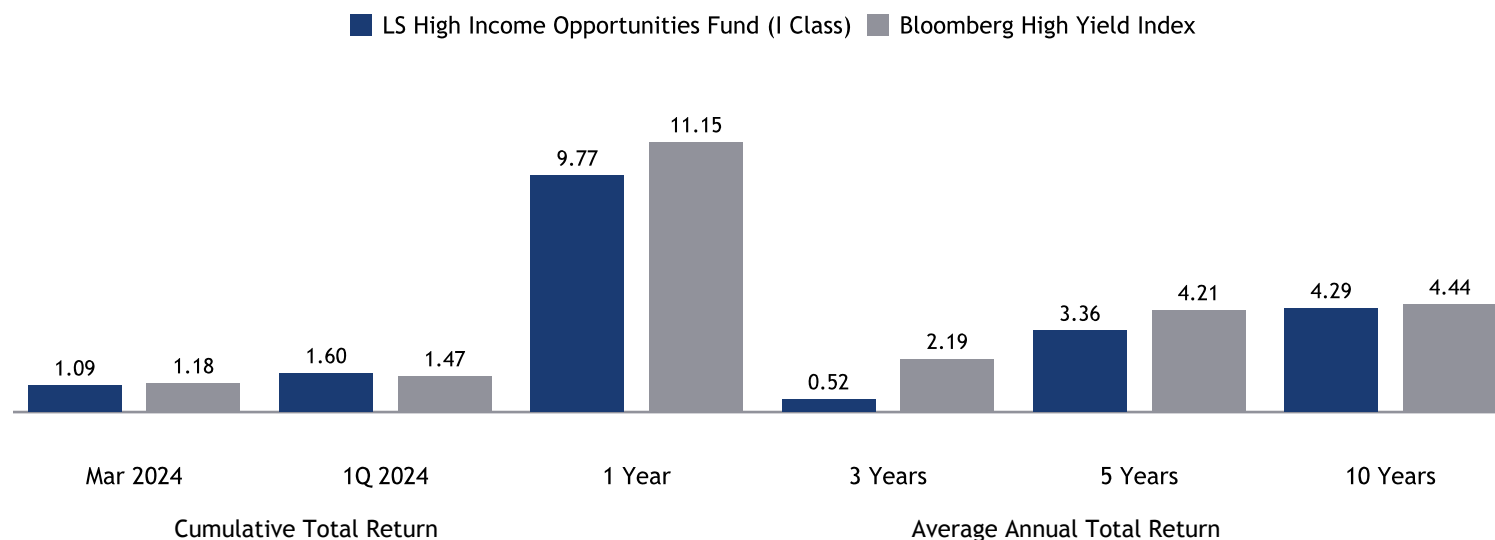

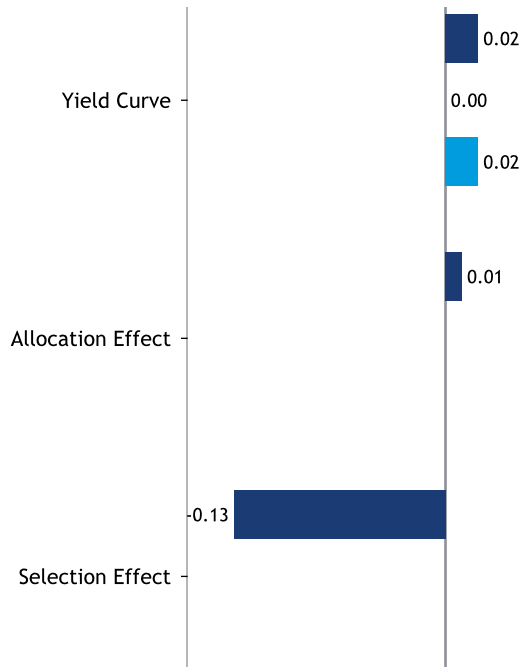

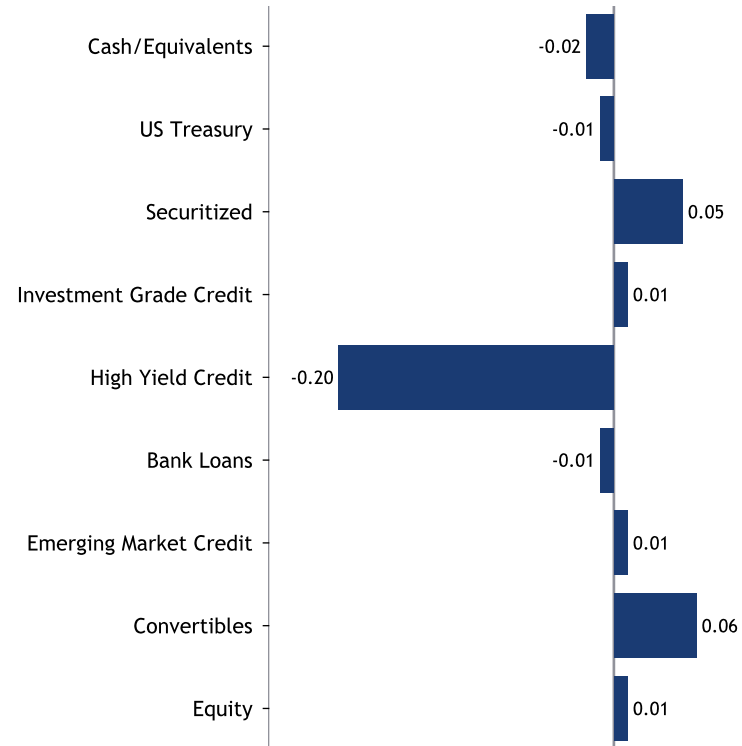

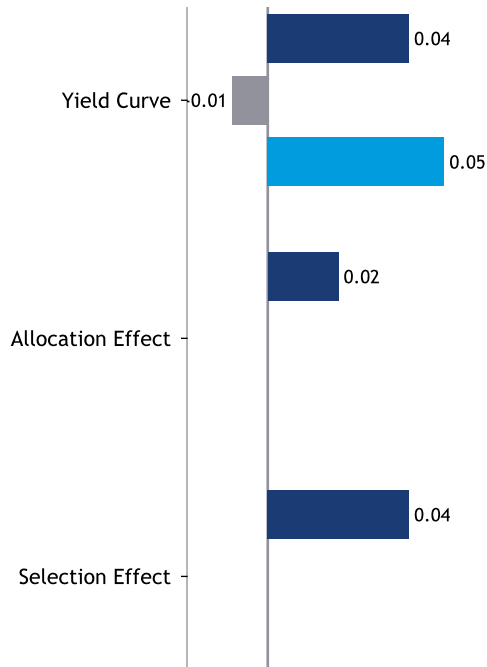

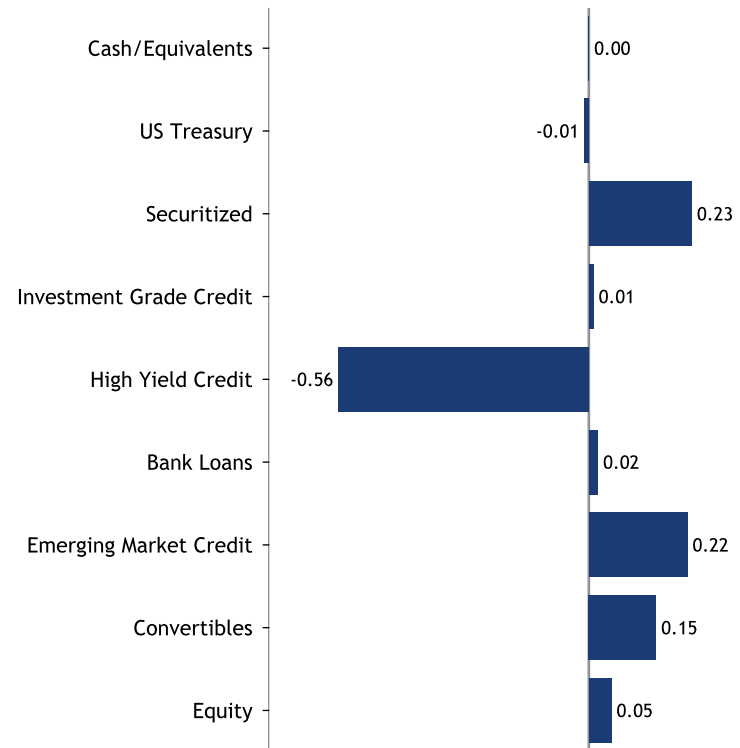

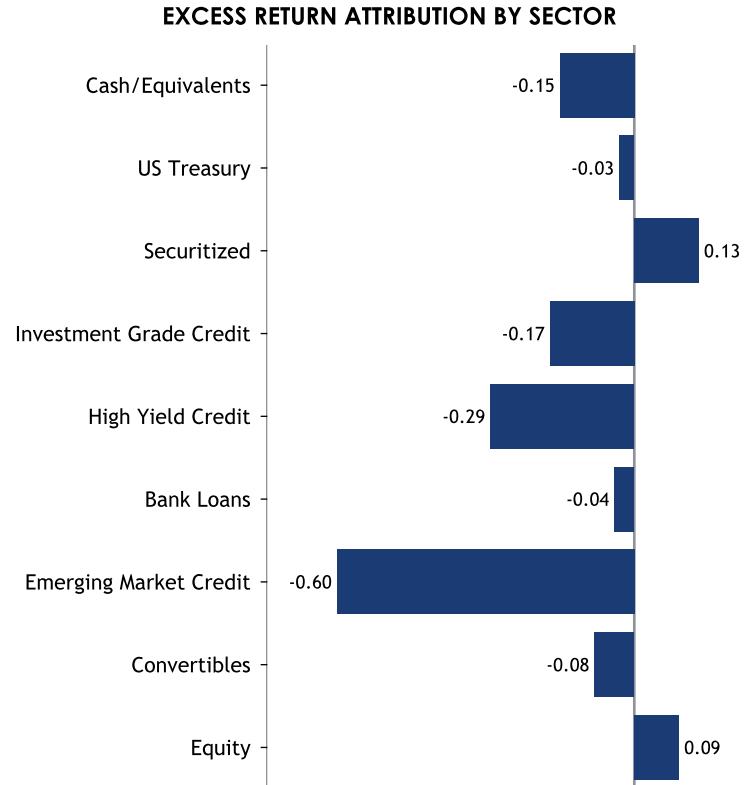
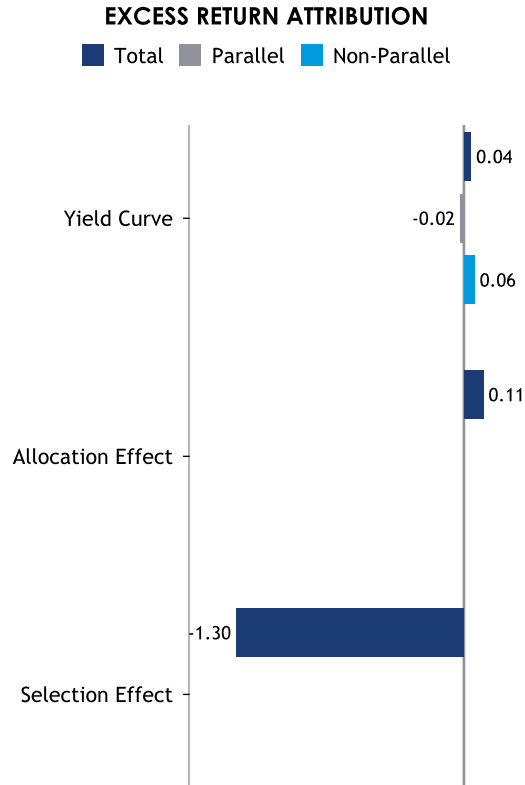

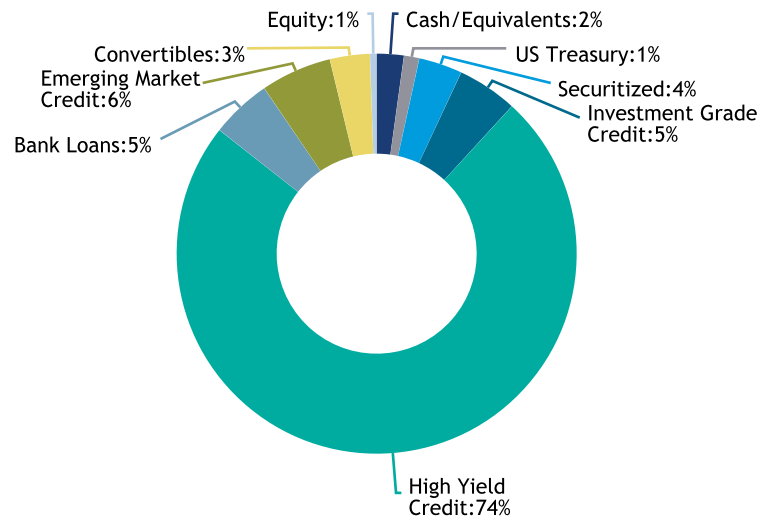

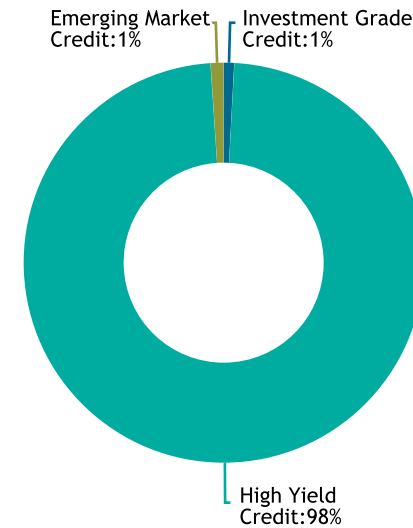

Additional Notes
